In his 11th year as Head Wrestling Coach of Wheaton Thunder Wrestling, Jim has coached 22 National Qualifiers and 9 All-Americans, and led the team to a CCIW team title. Gruenwald came to Wheaton after serving as an assistant coach for US Greco Roman wrestling team at the US Olympic Education Center in Marquette, MI from 2005- 2009 where he coached several World and Olympic Team members and medalists. As an athlete, Gruenwald, a 5x World and Olympic Team Member, finished 6th at 60 kg in the Greco Roman competition at the 2000 Olympics in Sydney and was 10th at the 2004 Olympics in Athens. He was also a 1998 and 2003 Pan American Champion, 2002 World Cup Champion, and placed 10th, 8th and 4th in the 2001-2003 World Championships, respectively. A three-time US Champion, he completed his competitive career in 2008 as a National Champion; he also won titles in 2003 and 2004. In college, Gruenwald finished with a 154-19 record and was a part of the prestigious Midlands 20 win club. As a high school wrestler, Jim was a 3x state finalist in WI, won a state title in 1987, and placed 2nd and 3rd at the Junior National Tournament (Fargo). He and his wife have 7 children and Jim has spoken extensively to all age groups including churches, businesses, the Military (ROTC and Officer Training Schools), camps, coach's seminars, and youth groups.


